Message From Chairperson



INSEC presents this Annual Report 2018 with its sincere thanks to all the contributors engaged to achieve its strategic targets. This report covers the achievements and engagements undertaken from 16 July 2017 to 15 July 2018. This report has highlighted thematic performance under human rights monitoring and documentation, human rights education, human rights advocacy and institutional capacity development. The performance and achievements are strongly correlated with the strategic objectives and targets of the institution. INSEC has documented the evidence of its achievement to validate its claim as well. The rigorous engagement to monitor, record and report the cases of human rights violation and possible response to the survivors, advocating to enlarge the civic space, human rights friendly legal environment, democratic process and rule of law for social justice, empowerment of people on human rights principles are the key identity of INSEC. I believe that the impartial and quality engagement of our team in protecting and promoting human rights is expanding peoples' trust towards it.

This reporting period is important for us because this is the first year after the completion of the three spheres of election and placement of elected governments. As one of the pioneer human rights organizations in Nepal, INSEC has engaged with the governments and legislature to advocate for human rights friendly laws, policies and plans. Similarly, INSEC's engagement was more concentrated on dialogues meant for further strengthening civic space. The executive decisions against the constitutional mandate to civil society organizations were challenged by us. As a result

they were cancelled. INSEC has intensely observed the democratic process and has contributed to strengthen democratic system, fundamental rights, press freedom and, independent fair and competent judiciary ultimately for more peaceful and more prosperous Nepal.

Serious national concerns such as truth and reconciliation were neglected by the state in this year too. We created pressure and disseminated the facts available in our documentation to contribute to the rights of the conflict victims. INSEC strongly appeals to the political forces and legislature to engage more to ensure the justice of the people. Impunity in the cases of serious crime against humanity is not acceptable in the modern society. INSEC has keen interest to question to the gov-ernment on their delivery to the people. Are the political parties leading in power at different levels of governments delivering the result to the people as per the constitutional mandate and their political manifesto? This is and important question to sustain democratic republic in Nepal. I believe that there are spaces for civil society to further strengthen the democratic republic in Nepal.

During this year, INSEC carried out its usual activities like publication of the year book 2018 which has documented the incidents of human rights violation and abuses across the country. We focused on enabling the people, especially women and children from the marginalized communities to assert for their rights to education, food and health. They have been capacitated through various activities to make claims on economic, social and cultural rights to the concerned government stakeholders. Furthermore, INSEC put efforts in exerting pressure for the ratification of international human rights treaties, their domestication and effective implementation, among others. Furthermore, INSEC facilitated initiatives to localize disaster risk reduction preparedness knowledge and mobilization of the youths for their capacity enhancement.

With the above note, I would like to highly appreciate the contribution of INSEC Chairperson Mr. Subodh Raj Pyakurel during this tenure for his leadership, policy guidance and continuous mentoring. INSEC expresses its sincere gratitude to the partners and donors who have trusted to our goal. I believe that the achievements are possible with the proper utilization of the resources. The collective efforts, partnership and collaborative interventions with all our well-wishers are also important in this journey. I would like to thank INSEC executive committee members, staff and volunteers for their continued commitment to achieving our goals towards protection and promotion of human rights. INSEC in Summary

Informal Sector Service Centre (INSEC) is a non-governmental organization. Established in 1989 with the aim of protecting the rights of people, it has been contributing since then to protecting and promoting fundamental rights of people virtually in all sectors of Nepal. INSEC's programs are geared towards protecting human rights via monitoring and documenting human rights situation, capacitating people and institutions for claiming their rights and advocating for human rights friendly legal and policy environment. As one of the leading CSOs in Nepal, it has facilitated public collaborations and networks for enhancing accountability and responsiveness on the part of service agencies and the government. During armed conflict in the past and thereafter as well, INSEC played crucial roles in protecting peoples' lives and rights. INSEC still works for the public as a vibrant civil society organization with unflinching sense of solidarity to democratic polity and liberal society.

INSEC movement is known nationally and internationally as an effort towards protecting people's rights, popular mobilization, capacitating state institutions and promoting accountability of the state machineries. INSEC believes itself as a campaigner to promote "human rights for all". Hence, it has worked incessantly for the enactment of human rights friendly laws, policies and plans ultimately aiming at further strengthening human rights culture in the country. Specifically, monitoring, documenting and reporting of human rights situation in Nepal has been a hallmark of this organization. INSEC has been publishing Nepal Human Rights Yearbook since 1992 and coordinating civil society networks in an international, regional and national contexts.

INSEC works in all 77 districts of the country through its provincial offices. In areas where it does not have district offices, it works through district representatives, who are in all the 77 districts. INSEC's core programs are implemented through its provincial and central offices. In addition, it also implements short-term projects at the federal, provincial and local levels.

INSEC beneficiaries are grassroots level people, vulnerable and marginalized community including Dalits, women, ex-kamaiyas, ex-haliyas, the victims of human rights violation (HRV) and abuses, students, government authorities, policy makers and HRDs, among others. INSEC is the Secretariat of Human Rights Treaty Monitoring Coordination Centre (HRTMCC), a network of more than 78 human rights NGOs at national level. INSEC also works as the Secretariat of Nepal NGO Coalition for the Universal Periodic Review (NNC-UPR) – a coalition of more than 295 active organizations as members.

INSEC works under partnership and plans. Currently, Norwegian Embassy (RNE), Governance Facility (GF) and Bread for the World (BftW) are its strategic partners. In addition, INSEC has been operating numbers of periodic projects. These projects have been supported by Dan Church Aid (DCA), The Finnish NGO Foundation for Human Rights (KIOS), Fredskorpset (FK), FHI 360 and Japan International Cooperation Agency (JICA), among others.





A. Human Rights Monitoring, Reporting and Documentation Programme

This programme aims to contribute to the protection and pro motion of human rights in the country through monitoring and documentation of human rights violations or abuses across the country. To materialize this objective, INSEC has established and regularly updated the human rights news portal - www.inseconline. org, the first human, rights news portal of Nepal launched in 2004. Under the programme, situation of human rights monitored during a year from across the

country is published in the form of Nepal Human Rights Year Book (NHRYB). The long-term objective of This program is to discourage human rights violation or abuses and to increase the access of victims of Human Rights Violations to justice. Also, INSEC provides emergency support including monetary or other services to the needy victims including Human Rights Defenders. In addition, press release and fact finding missions are carried out to support the achievement of the project goal.



Justice Ensured to Victim of Domestic Violence

fter four months of marriage, Bini Pariyar (name changed), 19 of Bhakimli, Myagdi, had started being coming the victim of domestic violence. Drunk, her husband used to beat her every day. According to the victim, she had been facing the same violation for last 13 years.

On 27th September 2017, while she was cleaning her house for Dashain, her husband started beating up her and asked her to give him the earring that she was wearing. When she denied, her husband attacked her simply to pull her earring from ears. She got injured then fainted as her ear was torn severely. On 28th September, her Sister-in-Law took her to Dhaulagiri Zonal Hospital for treatment and got her ear stitched. She wanted to lodge a complaint on the same day, but her neighbors stopped her from doing it as it was the festive time. For some days, her husband acted so normal after the suggestion of neighbors. But again, on 21st October, on the day of Bhaitika of Tihar festival, he beat up her and nearly killed. On the following day, with the support of Ward Chair she went to office of INSEC District Representative along with her children. With the initiation of INSEC, she wrote an application to District Police Office, Myagdi for justice and was taken for health treatment. After a long discussion at the Office with victim on 29th October, her husband agreed not to beat up her again. They reached a written agreement. During a follow up visit to her, she told INSEC representative that things are fine with her now and her husband has never beaten her since the agreement reached.

ilak Prasad Bhattarai of Bhimsen Rural Municipality-4, Gorkha was deprived of getting government relief provisioned for earthquake victims simply because his name was missing in the list due to mistake on the part of government authorities. On 18th March 2017, victim Bhattarai contacted INSEC District Representative and shared his problem. On the same day, the Representative took him to the office of the National Reconstruction Authority and supported him to fill up the form for receiving entitlements. Bhattarai's problem was known to INSEC after it held an interaction on the rights of earthquake victims. He was

not getting the grant amount even after receiving white and red card in January 2016. He was denied services whereas other victims had already received the stipulated amount of three lakhs for reconstruction. His name was missing on the list of first installment. Nonetheless, he was able to receive agreement paper of reconstruction on October 10, 2017 with the support from the Representative. After the devastating earthquake, the victim had received NPR 15,000 to construct temporary hut and was living in the hut with six family members very inconveniently. After the agreement, he received NPR 50,000 from the government. Reconstruction Corporation, Gorkha informed that the remaining amount will be paid soon.

Support to the Victim of Domestic Violence

Rural Municipality in Sindhupalchowk district injured his wife Maiya Tamang, 38, by hitting her with a rod in her head on 25th February 2018.

She wrote an application against domestic violence to INSEC district Office, Sindhupalchowk asking for support and justice. With the initiation of Natibabu Dhital, District Representative of INSEC, an FIR was filed against Raute Tamang at District Police Office on 26th February 2018. The victim sustained injuries in various parts of her body including in her head. Doctors at Chautara Hospital had had sutures in her head. For further treatment, she was referred to Kavre Hospital and INSEC provided NPR 5000 as a support for her treatment there.

According to Harikrishna KC, police inspector from District Police Office, Raute was arrested and kept in custody on 26th February 2018 for further investigation on the incident.

Bote Children Admitted at Orphanage

Here Bote, 15, and her brother Buddha Bote, 10, of Khanigaun village of Baganaskali Rural Municipality-7 in Palpa district were orphaned. Following their parents' death, they had been living with their grandmother however, unfortunately, they lost her too. Buddha is a healthy child, but his sister is physically disabled. She can hardly support herself.

On 11 November 2017, INSEC District Representative visited them and identified the problems after which he organized an interaction programme in the community. On 12 November 2017, the photo feature of this interaction programme was published on INSEC's online web portal. As an impact of the news feature, Krishna Prasad Basyal, Chairperson of the Municipality visited the victim's place, and committed to re-establish them. Later, in coordination with Ward Office and other organizations working for women and children, INSEC District Representative further updated the orphans' situation to report to CDO Bishnu Prasad Dhakal, who initiated immediate arrangement of food, shelter and their education. From 15th November 2017, Hema and Buddha started living at Silom Orphanage operated by Children's Campaign Nepal in Tansen.

During the process to admit them to the Orphanage, their births were registered. Purna Narayan Shrestha, Chairperson of the Campaign Nepal said that the orphanage had been providing with food shelter and education for them. Currently, Hema and Buddha are living very happily. Silom Orphanage informed that Hema's physical and mental health is slowly improving and she has been given required medical attention.

Disabled Conflict Victim Receives Support for Treatment

Indra Bahadur B.K.,57 of Kohalpur Municipality-2, Banke was beaten up by the former Maoist members in armed conflict accusing him of spying against them. His legs were fractured and were not properly treated due to his poor economic condition. He had not received any kind of compensation from any organizations. Currently, he lives at Fultekra, Nepalgunj. On 16th April 2018, he applied at the District Admistration Offce (DAO), Banke asking for required support for his treatment.

As the DAO did not pay attention to his situation and application, INSEC took him to Bheri Zonal Hospital, Nepalgunj. INSEC requested Dr. Prakash Bahadur Thapa for his free of cost treatment. On 2nd May 2018, INSEC provided him with NPR 10, 000 for transportation and treatment support. As per the approval of INSEC, Bheri Zonal Hospital, Nepalgunj helped him for this further treatment.

B. Human Rights Awareness Programme

Success Stories

HRWG Leads for Cleanliness of Municipality

Gurbhakot Municipality in Surkhet district did not use to be well managed from the point of view of sanitation and garbage management. Market places used to be unhygienic. Vegetable market, pig farms, slaughterhouses and residential area always remained in a mess nearby garbage dumping areas.

Realizing the health hazards caused by the situation, Gurbhakot HRWG in coordination with the Municipality, took initiations to set the situation right. After several meetings with the Municipality authority, the HRWG prepared an action plan for the improvement before submitting it to the Municipality authority. The HRWG then conducted interaction on 6, September 2017 and formed an 18-member committee for sanitation issues of the Municipality. Under the leadership of HRWG, numbers of organizations and groups such as consumer groups, local elected representatives at ward levels, mother groups, youth groups and other stakeholders collaborated in the effort of the HRWG, ultimately maintaining cleanliness.

HRWGs Establish Immunization Center

hodsuwa area of Ward 11 of Dhangadhi Metropolitan city had no fixed place for vaccinating children. The government of Nepal has been conducting programs to provide vitamins and polio vaccines periodically. However, administrating vaccines on children, due to lack of fixed place to attend, had been a problem for health workers for long. Conducting the immunization spree in open spaces or sometimes at private buildings tended to miss numbers of children from getting immunized.

In the initiation of HRWGs at Dhangadhi, in December 2017, a formal demand was put forth demanding there be a permanent immunization centre. Representatives from Ward Office, local health post authorities and other

local stakeholders supported the concept for establishing temporary immunization center.

As Ward Office of the Municipality supported with NPR 50,000 for maintenance and purchasing required equipment, HRWGs could well manage the center. Now, the periodic immunizations take place in the centre, on of the rooms of which has been used as a public library.

Orphans Admitted at SOS

A sheshwor Nepali and Rama Nepali were the residents of Banganka Municipality-8, in the district of Kapilvastu. They had three children. Within six months' period, both of them died. Maheshwor died in July 2017 and then his wife Rama in December of the same year.

The eldest son is eight years old and two daughters 6 years, and 6 months old. Orphaned, they were under the care of maternal uncle. The economic condition of the maternal uncle was so poor that he could not take care properly of the children so the latter had not been getting enough food and financial support for their bringing up and education. Their situation was published in local newspapers and online news portals on 5 February 2018.

After knowing the issue from the newspaper, human rights watch group of Kapilvastu immediately called a meeting on February 7 and submitted a memorandum to the CDO for the care of those orphans. Since one child was only six months old, it was difficult for the concerned organizations to take responsibility of care and nurture. The CDO office then had had contact with SOS office Bhairahawa and

introduced the case. SOS office Bhairahawa agreed to take responsibility of all three children. A team of CDO, police officers, journalists, watch group members and INSEC representatives then visited the house of the orphan. During the visit it was observed that the orphans had not been getting food and their uncle did not have money even for buying milk. The human rights watch group posted the information on social media and requested the public and concerned organizations for providing support to the children. As an impact of social media, Lumbini Society Kuwait provided NPR 51,000 and a Butwal based businessman provided logistic support of NPR 15,000. The amount hence received was provided to the children's uncle on February 24 as witnessed by Government officers, the representative of Lumbini Society Kuwait, INSEC, among others. On March 6, 2018, three children were formally admitted at SOS Bhairahawa under the leadership of IN-SEC representative Nanda Ram Pokhrel as agreed in the meeting held at CDO office.

ommunity schools at Ward No.6 of Laxmipur Rural Municipality in the district of Siraha had not been having good academic results of students for long. Irregularities on the part of teachers are primarily pinpointed for the bad performance. Late opening schools and closing classes early was a norm. Despite this reality, situation had not been changing for good.

Human Rights Watch Group (HRWG) members in the Ward raised this concern pro-actively and concluded that irregularity was the cause of poor performance. HRWG organized meetings and interactions among stakeholders and the beneficiaries. Ward level elected representatives were pushed to act for reforming school environments. With the initiation and pressure from the HRWG, elected representatives of the Municipality started a sustained monitoring of teaching learning status and environment of the schools as a result of which schools got regular and in time. Parents and other stakeholders believe now that this change will be a foundation for improving quality education of schools of their localities.

Ambulance Service Resumes in Jahada Rural Municipality: Thanks to HRWG

For more than 3 years, ambulance in Jahada Rural Municipality in Morang district was in a critical condition. It had not been maintained so was not functional. Community people were deprived from the services. Jahada Human Rights Watch Group (HRWG) came to know about the dysfunctional ambulance service in an interaction conducted in the locality. Immediately following the interaction, HRWG in Jahada conducted follow up meeting among beneficiaries and the Municipal authorities regularly as to making the ambulance service functional and easily available.

Meeting Minutes

The socio-economic condition of Bote and Kumal communities in Bagnaskali Rural Municipality, Palpa is very poor. They are one of the disadvantaged communities in the district. The District Human Rights Watch Group formed by INSEC raised concerns on their situations in a meeting of Bagnaskali Rural Municipality on February 2, 2018. After hearing the issue, the Municipality had had field visits starting on February 9 to these communities. After the field visit, they identified actual situation of these community and decided to provide necessary support for increasing their socio-economic conditions. Initially the Municipality held discussion with the community people. The discussion reached a conclusion that their situation could be uplifted via agro-based support and engagement. Accordingly, the agriculture department of the Municipality distributed tools and seeds to cultivate hybrid vegetables specifically to the Botes and the Kumals from Ward Nos. 1, 6 and 7.

A total of 60 families received such the facilities. The Municipality further provided training to the target families on vegetable farming and animal husbandry. By this report was prepared no visible result of their tools, seeds and training was visible. However, Krishna Prasad Basyal, Chairperson of the Municipality said that the Municipality would play the role of moderator for the farmer and would provide regular support to uplift their living conditions.

Human Rights Advocacy Programme



The main objective of Human Rights Advocacy Programme is to advocate for humanrights friendly policies and laws in compliance with international human rights instruments and to lobby for their proper implementation. INSEC has been taking up advocacy efforts in collaboration with other like-minded organizations at the national level. It has regularly

organized campaigns and advocacy for the human rights promotion and works on national level advocacy for ratification and domestication of international treaties. It monitors the status of implementation of international treaties and conventions by state and advocates for corrective action in compliance with national and international human rights standard.

Key Achievements



Project contribution and flagship events

A. Strengthening Enabling Environment for Civil Society Organizations in Nepal

NSE has been implementing the project "Strengthening Enabling Environment for Civil Society Organization in Nepal" in partnership with FHI 360 under Civil Society Mutual Accountability Project (CS: MAP) grant for the period of December 2016 to September 2020 (46 months). INSEC as national level civil society organization, contributes to standardize CSO related regulatory laws and policies to the international standard. Besides, INSEC facilitates dialogues and interactions to improve the internal governance and public perception of Nepali civil society organizations. In addition, INSEC has implemented this project as one of its initiatives to advocate for protecting and promoting the right to freedom of association and assembly. During the transition from centralized unitary state structure to the three spheres of governments (federal administrative structure), the policy debate regarding civil space became one of the prominent issue in the recent years. The objectives of the project are as follows:

- To improve legal and policy framework, based on international standards to create an enabling environment for civil society
- To improve public understanding and confidence in the role of civil society organizations
- To improve self-regulation of the sector and internal governance of CSOs

Major Achievements:

- INSEC has engaged at different levels (Office of the Prime Minister and the council of Ministers to the provincial parliament) to share the concerns of civil society and the need of CSOs friendly legal and policy environment.
- INSEC has facilitated district level inter actions with journalists, local government representatives, line agencies and stakeholders to improve the civil society engagement in the local development with the improved skill, knowledge and public image.

B. Sahakarya (Coordination) : Youth Exchange Program

S ahakarya is the youth exchange program jointly implemented by INSEC and People's Vigilance Committee on Human Rights (PVCHR), India. Youths working in the field of human rights and community development from Nepal and India are selected for the program. During the selection; the priority is given to women and youths from underprivileged community. During the fellowship period partici-pants spend one week in Norway, four months in Nepal and another four months in India involving in various social and community develop- mental activities.

Objectives

The main objective of this program is to support young people's participation in the capacity and leadership development in local, regional and international levels.

Achievements

- Youths have developed skills on human rights documentation as well as communica-tion skills such as writing case studies and sending urgent actions.
- Youths have themselves been identifying the human rights issues and are using various laws and guidelines for doing intervention.
- Youths have been acting as local agent for making social change by imparting gained knowledge among adult women, adolescent girls and the minority children.
- Youths have been familiar with international contexts and cross-cultural issues, they are working directly with the community to reduce caste-based discriminations and other forms of violence.

C. School Based Sustainable Disaster Risk Reduction Education and Material Development Project



Disaster Risk Reduction Education Awareness Event for Students, Kathmandu

The project titled, 'School Based Sustainable Disaster Risk Reduction (DRR) and Material Development Project' Started in December 2016. Funded by Japan International Cooperation Agency (JICA), CITYNET Yokohama and Plus Arts and Kobe are the collaborative partners for the project. The project covers 20 schools of five municipalities of Kathmandu, Lalitpur, Bhaktapur districts. The project trains local teachers to develop DRR learning tools by using locally available tools and conduct various DRR Awareness Activities at different municipalities.

Objectives of the project

- To localize DRR tools and develop DRR learning materials for the children
- To conduct DRR Awareness Activities at School and Community Level
- To familiarize with Japanese Practices on DRR and develop own practice manual

Achievements

- 36 teachers are trained on DRR education and have developed 10 DRR education tool kit for students
- 5 Disaster Awareness Events are conducted in five municipalities
- More than 500 students are familiar with disaster risk reduction tools

Objectives of the project:

- To Strengthen the capacity of elected representatives in local and province level
- To develop training manual for the newly elected bodies for guiding on human rights principles
- To strengthen local level help desk to address local level human rights issues


Major achievements






INSEC Library


